**ENTERTAINMENT AGREEMENT**

**THE PARTIES:** This agreement is for mobile disc jockey entertainment services for the event described below, between the undersigned Client and Forever Young D.J.

**PAYMENT TERMS:** Total fee agreed upon by Client and Forever Young D.J. is \$\_\_\_\_\_. To confirm this Agreement, return one signed and completed copy along with a deposit of half the amount agreed upon. Agreements received are subject to availability. The balance is due no later than the date of the event unless otherwise previously arranged, and may be paid with a check; cash; money order; or credit card. There will be a 4% service charge for all credit cards. All checks should be made payable to Forever Young D.J. There will be a \$30.00 fee charged for all returned checks. Gratuities given to a Disc Jockey at an event are appreciated and made at the sole discretion of the Client.

**CANCELLATION:** This Agreement cannot be canceled or modified except in writing by either the Client or Forever Young D.J. If the Client initiates cancellation less than 60 days prior to the event, then the deposit will be forfeited. For cancellations less than 30 days prior to the event, Client is responsible for the total fee OR may forfeit deposit only by signing a new Entertainment Agreement with Forever Young D.J. within two weeks of cancellation for a substitute engagement performed in the following six months. Rescheduling for events canceled due to inclement weather shall be accommodated whenever possible. Rescheduled events are subject to availability.

**OVERTIME COSTS:** When feasible, Client request for extended playing time during event will be accommodated. Overtime requested may be made in half-hour increments at a cost of \$50.00 per half-hour. Payment for overtime is due on the date of the event, and may be made with cash, check, or credit.

**LATE FEES:** The Client agrees to pay Forever Young DJ the balance due, on or before listed date, Should the Client fail to do so, the client agrees to pay a \$50.00 late fee plus 10% per week interest on the final balance due and all other costs and expenses including court and associated costs.

**PROVISIONS:** The Client shall ensure that: (1) performance facility provides DJ with a sturdy covered

table approximately 2x8 feet (weddings only) in an area with 25 feet of a 110-volt outlet (3 prong grounded); (2) facility is open at least one hour prior to scheduled start time; (3) meets all federal and state safety regulations and has all appropriate music licenses and performance permits; (4) reasonable steps will be taken to protect Forever Young D.J.'s equipment, personnel, and music, and crowd control will be provided if warranted; (5) for outdoor performances, shelter is provided that completely covers and protects Forever Young D.J.'s equipment from adverse weather conditions.

Client accepts full responsibility and is liable for any damages, injuries, or delays that occur as a result of failure to comply with these provisions. In the event of circumstances deemed by DJ to present a real or implied threat of injury or harm to DJ, equipment, or recordings, then DJ reserves the right to cease performance until such time as Client resolves the threatening situation. DJ further reserves the right to deny any guest access to recordings or equipment. In the unlikely event the DJ's performance is delayed, liability is limited to providing Client with performance time equal to time lacking. Forever Young D.J. holds all appropriate insurance for its equipment and personnel. Forever Young D.J. reserves the right to appoint appropriate personnel to mc/disc jockey an event based on their experience.

**DISCLAIMER:** In regards to events with formalities, unless all paperwork (formality sheets), arrangements finalized, music selections have been made and received by Forever Young D.J. two weeks prior to event, Forever Young D.J. will not be liable for problems that may occur due to this lack of communication by client.

**OUT OF TOWN EXPENSE:** Any event out of Tarrant County area will be charged a minimum of \$50.00 traveling expense. Any event outside of the DFW area will also be charged a \$1/mile fee.
